# Day Boarding Agreement

## **General Agreement**

This policy ensures the safety and well-being of all dogs in the facility, providing a structured and enjoyable environment for dog day boarding with play.

# For protection and comfort of all dogs and people frequenting K9 Social area please respect the following requests

- All dogs must be healthy and not sick upon arrival they maybe refused if found unwell.
- All dogs must be vaccinated within the last 12 months.
- All dogs worming must be up to date.
- All dogs must be free from parasites such as fleas and ticks.
- All dogs enter and leave on a leash
- All dogs must be toileted prior to arrival

Your dog will be in the company of a team of experienced trained staff, who have the skills and knowledge to make their stay safe and pleasurable through positive reinforcement.

## Risks - Whilst the upmost care is taken,

- -Owners acknowledge that dogs are unpredictable in behaviour and are aware of the risks involved in such play and assume all risks. -In the unlikely event that, veterinary treatment is required which has an imminent impact on a pet's health, the owner gives consent for his establishment to seek treatment for the pet at the closest local veterinary clinic.
- -We are NOT liable for any vet related costs
- -Owners understand that supervised off-leash socialisation and interaction between people and dogs is encouraged if you allow.
- -It is your responsibility to let us know if you DONT want your dog to mingle with other dogs or humans

**Not all dogs are suited to Day Boarding or Day Boarding with play**, if we find your dog is highly stressed or not suited to this environment, we may politely refuse the service. #### **Detailed Day Boarding Agreement**

- -This agreement contains the entire agreement of the parties with respect to the subject matter contained herein, and supersedes all prior negotiations, agreements and understandings between the parties. Your acceptance of this agreement is constituted by signing this agreement below, and subsequent submission of this application to us.
- 2. Day boarding
- -Sandys Grooming Tails & K9 Cafe will provide a clean, safe, and secure environment for your dog while it is in our care.
- -Dogs left at our daycare may be taken off the premises periodically by one of our staff for routine walks. We may, at our sole discretion, use our own leashes and/or collars on your dog while it is in our care.

We are not responsible for any damages to, or loss of, any personal property you leave in our care, including, but not limited to, leashes and collars.

Except for routine walks or emergency medical service, your dog will not be taken off of the premises of the daycare facility at which you left it without your express consent.

-All dogs left in our care must be up to date on, as well as a flea and tick preventative. It is your responsibility to continually provide us with updated shot records as it becomes necessary. By bringing your dog to us, you assert that they are up to date on all required vaccinations, whether or not you provided proof of such vaccinations. Further, you agree that, should you fail to keep your dog's vaccinations up to date, you will be held fully liable for any and all expenses and/or damages incurred by Sandys Grooming Tails & K9 Cafe

as a result of that failure.

- -If your dog experiences any medical problem while in our care, we will first attempt to contact you via the method you selected for this purpose on our application form. If we are unable to contact you, we will attempt to contact the dog's co-owner (if applicable), and then the emergency contact you specified. If we are unable to contact any of these people for instructions, or if we deem the problem to be a medical emergency, we will transport your dog to a licensed veterinarian of our choosing for treatment. If this occurs, we are in no way liable for any damage caused to your dog by transportation and/or treatment. Additionally, any costs of such treatment are solely your responsibility, and if we pay for any treatments or medications at the time they are administered, you are responsible to reimburse us for the full amount of any expenses within 24 hours.
- -If your dog bites another dog or a human while in our care, you agree to be fully liable or any such actions. You hereby release us from any and all liability that may result from such events.
- -You understand that when you leave your dog in our care, unless stated not to, your dog may engage in supervised play with other dogs. As such, it may occasionally suffer scratches and/or minor bites. This is a normal occurrence at a dog daycare, and you agree that the infliction of any such minor wounds does not constitute a breach of Sandys Grooming Tails & K9 Cafes obligation to provide a safe and secure environment for your dog.
- -Under no circumstances is Sandys Grooming Tails & K9 Cafe responsible for any injury, death, or contraction of disease of any dog in our care. By bringing your dog to a daycare, you are exposing them to an increased risk of injury and disease. You hereby release us from any and all liability for any damages that may occur while your dog is in our care.
- -If you choose to leave us keys to your home, for the purpose of picking up or dropping off your dog, you release us from any and all liability for any damages or loss that may occur as a result of us having keys to, or accessing, your home.
- -We may refuse to provide any services to any person, at any time, for any reason, and likewise may refuse to allow any dog to enter a daycare at any time, for any reason, regardless of whether it has been accepted into the daycare previously.
- 3. Media
- -We retain the right to take photographs and/or videos of your dog while it is in our care, and by bringing your dog to one of our daycare facilities, you grant us permission to use and copyright any images, videos, or likenesses of your dog, created by us or under our direction, indefinitely and for any reason, without notification or compensation to you.
- 4. Email Subscription List
- -When you use our services, the email address you provide will be automatically added to our mailing list. Sandys Grooming Tails & K9 Cafe will aim to provide any notifications of rate changes, updates to these terms, and emergency closures by way of an email sent to all recipients on this list. As such, it is solely your responsibility to check this email for any notifications from us, and to provide us with any updates as to the email address to which we should deliver such notices.
- 6. Severability
- -In the event that any of the terms of this contract are held unenforceable, all remaining terms of this contract shall remain in full force and effect.
- 7. Non-Waiver
- -The failure of Sandys Grooming Tails & K9 Cafe to enforce any of the terms of this contract does not affect our right to enforce any or all the terms at any time thereafter.
